<b>INFORMATION</b>	

MARTIN C. BEESON, District Attorney for the Ninth Judicial District, State of Colorado, in the name and by the authority of the People of the State of Colorado, informs the Court:

**COUNT ONE**

That on or about December 25, 2009, in the County of Pitkin, State of Colorado, CARLOS IRWIN ESTEVEZ, by any threat or physical action unlawfully, feloniously, and knowingly placed or attempted to place Brooke Mueller in fear of imminent serious bodily injury by use of a deadly weapon or any article used or fashioned in a manner to cause a person to reasonably believe that the article was a deadly weapon, namely: a knife; in violation of section 18-3-206(1)(a)/(b), C.R.S., as amended, contrary to the form of the statute in such case made and provided, and against the peace and dignity of the People of the State of Colorado, and thereby did commit the crime of MENACING, (F5), which act constituted an act of domestic violence.

**COUNT TWO**

That on or about December 25, 2009, in the County of Pitkin, State of Colorado, CARLOS IRWIN ESTEVEZ unlawfully, knowingly, or recklessly caused bodily injury to Brooke Mueller; in violation of section 18-3-204, C.R.S., as amended, contrary to the form of the statute in such case made and provided, and against the peace and dignity of the People of the State of Colorado, and thereby did commit the crime of ASSAULT IN THE THIRD DEGREE, (M1), which act constituted an act of domestic violence.

COUNT THREE

That on or about December 25, 2009, in the County of Pitkin, State of Colorado, CARLOS IRWIN ESTEVEZ, in the course of a single criminal episode, unlawfully and knowingly damaged the real or personal property of Brooke Mueller, the aggregate damage being five hundred dollars or more but less than one thousand dollars; in violation of section 18-4-501, C.R.S., contrary to the form of the statute in such case made and provided, and against the peace and dignity of the People of the State of Colorado, and thereby did commit the crime of CRIMINAL MISCHIEF - \$500 - \$1,000, as amended, (M1), which act constituted an act of domestic violence.
