MR AND MRS BOSH DEPARTED THEIR HOUSE WITH THEIR HOUSE GUESTS AT APPROXIMATELY 7:30 PM TO ATTEND A PARTY IN HIS HONOR. ACCORDING TO MR AND MRS BOSH THEY LEFT THEIR TWO BABYSITTERS AT THE HOUSE WITH THEIR CHILDREN AND A TEENAGER. WHEN MR AND MRS BOSH RETURNED HOME AT APPROXIMATELY MIDNIGHT, MR BOSH WENT UPSTAIRS TO THE BEDROOM AND ENTERED THE WALK IN CLOSET. UPON ENTERING THE CLOSET, MR BOSH NOTICED TWO RINGS ON THE FLOOR; ONE OF THE RINGS WAS A CHAMPIONSHIP RING. MRS BOSH ENTERED THE CLOSET MINUTES LATER AND TOGETHER THEY REALIZED THAT THE CLOSET HAD BEEN RANSACKED AND ITEMS TAKEN. MR AND MRS BOSH, CONTACTED THEIR DIRECTOR OF SECURITY/MR HOLCOMBE AND ASSISTANT/MR GRAY. A CHECK OF THE REMAINDER OF THE PROPERTY INTERIOR AND EXTERIOR WAS CONDUCTED AND NO SIGNS OF FORCED ENTRY/DAMAGE OR THEFT WAS NOTICED. MRS BOSH REPORTED THAT SEVERAL PURSES TOTALING APPROXIMATELY \$155,000. DOLLARS, AND \$15,000 CASH WAS TAKEN FROM A SAFE ON HER SIDE OF THE WALK IN CLOSET. MR BOSH HAD TWO RINGS TOTALING \$4,000, \$5000 CASH, AND 12 WATCHES TOTALING OVER \$300,000 DOLLARS WAS TAKEN FROM HIS SIDE OF THE CLOSET. ACCORDING TO MR AND MRS BOSH THEY SPOKE WITH THE BABYSITTERS AND THE TEENAGER AND NEITHER OF THEM HEARD ANYTHING OR SAW ANYONE ELSE INSIDE THE HOUSE AFTER ALL OF THEM LEFT AT 7:30 PM. THE TEENAGER/~~██████~~ STATED THAT SHE WENT DOWNSTAIRS AT APPROXIMATELY 8:30 PM TO GET SOMETHING TO EAT FROM THE KITCHEN AND DID NOT SEE ANYONE ELSE INSIDE THE HOUSE. I CONDUCTED A CHECK OF THE EXTERIOR ALONG WITH MR BOSH AND DID NOT SEE ANY VISIBLE SIGNS OF DAMAGE OR FORCED ENTRY. MR BOSH STATES THAT THERE IS VIDEO SURVEILLANCE AND AN ALARM. THE ALARM WAS NOT ACTIVATED BECAUSE THE BABYSITTERS WERE HOME. CRIME SCENE WAS NOTIFIED AND CRIME SCENE TECH CONCEPCION #830 RESPONDED FOR PROCESSING. DETECTIVE SGT PRIETO/ AND TRAVIS/ RESPONDED. SGT BERRIAN AND LT RODRIGUEZ NOTIFIED AND RESPONDED. MR AND MRS BOSH ARE UNABLE TO PROVIDE SERIAL NUMBERS OF ITEMS TAKEN AT THIS TIME FOR FCIC/NCIC ENTRY.

DURING THE WALK-THROUGH I NOTICED THAT THE REAR DOOR ON THE BAY SIDE WAS UNLOCKED AND THE FRONT DOOR WAS UNLOCKED WHEN THE VICTIMS RETURNED.

SEVERAL HOMES ADJACENT TO THE VICTIM'S RESIDENCE ALSO APPEAR TO HAVE SURVEILLANCE SYSTEMS.

SECOND BABYSITTER: "TRACY" INSIDE RESIDENCE BABYSITTING BETWEEN TIMES MR/MRS BOSH GONE. ACCORDING TO MRS BOSH, "TRACY" RECENTLY HIRED APPROXIMATELY 4 MONTHS AGO.
