16 Name Charles Milles Manson a single man, living in State prison in California wishes to leave my
17 remaining estate to [REDACTED] I have two known children son
18 Michael Brunner, and son Charles Manson Jr. I have disinherited both known sons and any
19 unknown children in the present and in the future from my estate. Immediately Upon my death my
20 wishes are in leaving [REDACTED] my entire estate, my remaining cash funds left in my
21 account at Corcoran, my remaining property held by the state prison, my remaining clothing and
22 personal items held by the state prison system, any property belonging to B33920 Charles M.
23 Manson will be turned over to [REDACTED] I am leaving my entire estate to [REDACTED]
24 including my image rights, my music rights, all printing rights, my exclusive music catalog including
25 all music I have ever printed, written, sang, recorded, released or unreleased. I am turning over my
26 entire existing estate, Music and image rights, movie rights, publishing rights including exclusive
27 rights to my Name Charles Milles Manson. This living will was written in 2002 and is the latest
28 updated version signed in full by Me Charles Manson B33920 stating my wishes of my said estate
29 upon my death. I give my written permission here to release all files to [REDACTED]
30 including all Juvenile records, C- files, Public files and or Police records or prison records deemed to
31 be part of my estate. Upon my death all my property being held by any Institution, police force,
32 prison system, or property room be immediately released to said executor. [REDACTED] is the
33 only named person in my will and is the only recipient to my entire remaining estate. [REDACTED]
34 [REDACTED] will remain the only recipient to 100% of my estate unless another updated will is written
35 and signed by me Charles Manson and filed with the prison before my death, removing [REDACTED]
36 [REDACTED] from being the sole recipient of 100% of my estate and naming another person as sole
37 recipient and executor. If no update is filed [REDACTED] will be the sole recipient of my entire
38 estate. My wishes upon my death have been privately confided with [REDACTED] it will have him in
39 charge of the disposition of my remains as per side 2 of this Original Yellow two sided document,
40 page 2 lines 28-51. Upon my death I wish not to be held in state prison I want released
41 immediately to the custody of [REDACTED] per my private instructions on the disposition of
42 my remains, to be carried out by a professional mortuary facility, of [REDACTED] choosing,
43 under complete supervision of [REDACTED] my agent I have assigned to carry out my final
44 last wishes My full entire unmolested body be turned over to [REDACTED] immediately upon my
45 demise. I have forgiven no debts and the debts owed to me will be now part of the debts owed to
46 my estate and [REDACTED] I am leaving nothing to any such heirs as, relatives, children, ex-
47 wives, in-laws, lawyers, friends, prisoners, inmates, cops, guards, or the state of California. My
48 entire estate is being given and turned over to [REDACTED] including my remains (full
49 unmolested body). The State of California is to accept this document as a legal and binding will and
50 last testament of my Charles Manson B33920 last wishes. This document was originated on
51 February 14, 2002 and was read agreed upon as being what I want to have done with my
52 belongings, cash receipts, personal effects, crafts, clothing items, cell items, guitars, and paperwork,
53 files, prison documents, Photographs, recordings, Music, Music Catalog, Writings, Drawings, Artwork,
54 all included in the estate. I own all my own music and image rights, music catalogs and these
55 items are part of my estate. [REDACTED] and Charles Manson have discussed and agreed
on this will and last testament and have both signed page two of this document making it legal
and binding in a court of law from this said date on unless an updated version specifically excludes
out [REDACTED] including these provisions set forth by Charles Manson himself on this date
February 14, 2002:
Manson estate includes: Music rights, Image rights, printing rights, Music Catalogs, Music, writings,
artwork, drawings, spoken word, My likeness including the publishing rights, printing rights, internet
rights, These Rights are 100% exclusive to the Manson estate and have never been sold. Music is
100% exclusive to the Manson estate and includes over 100 songs in the Manson music catalog all
exclusive to the Charles Manson estate.
